Applications are invited only through online mode up to <u>09.09.2018</u> for direct recruitment to the posts included in <u>Combined Civil Services Examination–II (Interview Posts)</u> (<u>Group-II Services</u>) [Service Code No.004]

It is mandatory for the applicants to register their basic particulars through One Time Online Registration system on payment of Rs. 150/- (Rupees One Hundred and Fifty only) towards registration fee and then should apply online for this recruitment. [The One Time Registration will be valid for 5 years from the date of registration. Thereafter, the registration should be renewed by paying the prescribed fee.]

#### 2. DISTRIBUTION OF VACANCIES

The rule of reservation of appointment is applicable for this recruitment except to the shortfall vacancies. 4% reservation will be followed for the Differently Abled Persons for the posts included in CCSE-II services (Group-II Services)(Interview Posts), as identified in the G.O.(Ms) No. 51, dated 26.12.2017 & G.O.(Ms) No.20, dated 20.06.2018 Welfare of Differently Abled Persons (DAP.3.2) Department." (ANNEXURE -III). The distribution of vacancies for this recruitment will be announced later.

- 1. First, the selection will be made for the carried forward vacancies. [Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016]
- 2. Secondly, the selection will be made for regular vacancies following the rule of reservation.

3. Thirdly, the selection against shortfall vacancies will be made from among SC/ST applicants only. The reservation for Women, Ex-servicemen and Differently Abled Persons will not be applicable for the recruitment of shortfall vacancies. - Examination fee for Preliminary Examination Rs.100/- (Rupees One Hundred only) is payable by online through Net Banking/Credit card/Debit card or it can be paid by offline at State Bank of India / Indian Bank/post office within 2 days from the date of submission of online application by choosing the option in the online application.
- The fee for Main Written Examination should be paid through online by those who are to be admitted to the Main Written Examination, based on the result of Preliminary Examination, on receipt of intimation from the Tamil Nadu Public Service Commission, unless exemption of fee is claimed.
- Applicants have to register their basic particulars through One Time Registration which is mandatory on payment of Rs.150/- (Rupees One Hundred and Fifty only) towards registration fee and then should apply online for this recruitment. The One Time Registration will be valid for 5 years from the date of registration. Thereafter, the registration should be renewed by paying the prescribed fee. Applicants who had already registered in One Time Registration system by paying Rs.50/- before 01.03.2017 and

- having validity and those who have registered for One Time Registration system are exempted from paying the registration fee for this recruitment.
- Applicants have also to pay the service charges applicable to the State Bank of India / Indian Bank/ Post Office.
- Applicants can avail exemption from paying examination fee as per eligibility criteria.
- Offline mode of payment in the form of Demand Draft / Postal Order etc., will not be accepted and the applications forwarded with such modes of payment will be summarily rejected.

#### 7. CONCESSIONS

- (i) Concessions in the matter of age and/or fees allowed to SCs, SC(A)s, STs, MBCs/DCs, BCs(OBCM), BCMs, Destitute Widows, Differently Abled Persons, Ex-Servicemen and other categories of persons etc., are given in para 12 to 14 of "Instructions to Applicants").

#### Note:

#### **10. SELECTION PROCEDURE**

The selection will be made in three successive stages viz., (i) Preliminary Examination for selection of candidates for admission to the Main Written Examination (ii) Main Written Examination and (iii) an Oral Test in the shape of an Interview.

The Preliminary Examination is meant to serve as a screening test only. The marks obtained in the Preliminary Examination by the candidates who are declared qualified for admission to the Main Written Examination will not be counted for determining their final order of merit. The number of candidates to be admitted to the Main Written Examination will be 10 times the number of candidates to be recruited having regard to the rule of reservation of appointments. However, in each reservation group, all the candidates who secure the same marks as that of cut off marks of their reservation groups shall also be admitted to the Main Written Examination, though the number of candidates to be admitted to the Main Written Examination may exceed 1:10 ratio.

#### Note:

- 1. First, the selection will be made for the carried forward vacancies. [Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016]
- 2. Secondly, the selection will be made for regular vacancies following the rule of reservation.
- 3. Thirdly, the selection against shortfall vacancies will be made from among SC/ST applicants only. The reservation for Women, Ex-servicemen and Differently Abled Persons will not be applicable for the recruitment of shortfall vacancies. [Section 27(h) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016].

#### 11. NO OBJECTION CERTIFICATE / INFORMATION TO THE EMPLOYER

No Objection Certificate obtained from appropriate authority should be produced at the time of certificate verification failing which, the application will be rejected.

#### 12. GENERAL INFORMATION

A. The rule of reservation of appointments is applicable for this recruitment except to the shortfall vacancies and the District / Unit wise Distribution of vacancies will be announced later and will be subject to the orders to be received from the Government regarding identification of suitable categories of differently Abled Persons towards 4% reservation.

B. In G.O.(Ms.) No.145, Personnel and Administrative Reforms (S) Department, dated 30.09.2010, and G.O.(Ms.)No.40 Personnel and Administrative Reforms(S) Department dated 30.04.2014 the Government have issued orders to fill up 20% of all vacancies in direct recruitment on preferential basis to persons who studied the prescribed qualification in Tamil Medium. The 20% reservation of vacancies on preferential allotment to **Persons Studied in Tamil Medium (PSTM)** will apply for this recruitment. (Applicants claiming this reservation should have studied the prescribed qualification for the post in Tamil Medium and should have the certificate for the same. Having written the examinations in Tamil language alone will not qualify for claiming this reservation). If the applicants with PSTM Certificate are not available for selection for appointment against reserved turn, such turn shall be filled up by Non-PSTM applicants but belonging to the respective communal category. The PSTM certificate shall be produced / uploaded by the applicant in prescribed format / proforma available in the Commission's website at 'www.tnpsc.gov.in' which shall be obtained from the Head of the Institution.

- C. The number of vacancies advertised is only approximate and is liable for modification including reduction with reference to vacancy position at any time before finalisation of selection for Oral Test.
- D. The selection for appointment to the said posts are purely provisional subject to final orders on pending Writ Petitions, if any, filed at Madras High Court and Madurai Bench of Madras High Court.
- E. As per Section 26 of Tamil Nadu Government Servants (Conditions of Service) Act, 2016, 10% of vacancies out of 30% of vacancies set apart for Women candidates in direct recruitment are reserved for Destitute Widows in respect of the posts for which the scale of pay does not exceed Rs. 5200-20200 + Grade Pay 2800/- (PB 1). (as per pre revised scale)
- F. As per Section 27(c) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016, 5% of vacancies shall be set apart for Ex-Servicemen in the posts which are classified under Group-'C' (i.e.,) with the Grade Pay minimum of which Rs.1,400/- and above but below Rs.4,400/-.(as per pre revised scale) If no qualified and suitable Ex-Servicemen belonging to a particular category is available for selection for appointment against reserved turn, such turn shall be filled up by a candidate other than Ex-Servicemen but belonging to the particular communal category.
- G. The rule of reservation for appointment of the Differently Abled persons is applicable for this recruitment ,4% reservation will be followed for the posts included in CCSE-II (Group-II Services)(Interview Posts) ,as identified in the G.O.(Ms) No. 51 Dated: 26.12.2017 and G.O.(Ms) No.20, Dated: 20.06.2018 Welfare of Differently Abled Persons (DAP.3.2) Department (ANNEXURE III) . Hence, the Differently Abled Persons with disability of not less than 40% may apply to this recruitment. They should upload a copy of documents referred to in para. 14(b) of 'Instructions to Applicants' when called for.
- H. The Differently Abled persons should submit /upload a copy of Differently Abled Certificate from competent authority specifying the nature of physical handicap and the degree of disability when called for by the Tamil Nadu Public Service Commission.
- I. If no qualified and suitable women applicants are available for selection against the vacancies reserved for them, those vacancies will be filled by other applicants belonging to the respective communal categories.

- J. Even after filling up of the vacancies reserved for SC Arunthathiyars on preferential basis, if more number of qualified Arunthathiyars are available, they shall be entitled to compete with the Scheduled Castes
- K. Other than Arunthathiyars in the inter-se merit among them and if any posts reserved for Arunthathiyars remain unfilled for want of adequate number of qualified applicants, it shall be filled up by Scheduled Castes other than Arunthathiyars.
- L. Subsequent claims made after the submission of online application will not be entertained. Evidence for claims made in the online application should be uploaded / submitted in time when documents are called for. Failure to submit the documents within the stipulated time limit will entail rejection of application.
- M. Correct and True information regarding arrest, convictions / debarment / disqualification by any recruiting agency, criminal or any disciplinary proceedings initiated / pending or finalised, participation in agitation or any political organisation, candidature in election for parliament / state legislature / local bodies etc, if any, should also be furnished to the Commission at the time of application. The details thereof, i.e. originals of the judgement, order/ or G.O. dropping further action in departmental proceedings or any document that may prove the suitability of such applicants for government appointment in such cases must be produced at the stage / time of certificate verification without fail. All such events that occur after the submission of application and till the date of his/her selection and appointment shall be reported to the Commission forthwith then and there. Failure to report on the part of applicant will be considered as suppression of material information and will attract suitable penal action.
- N. Incomplete applications and applications containing wrong claims or incorrect particulars relating to category of reservation / preferential claim as PSTM / other basic qualification / eligibility wise / age / communal categories / educational qualification / physical qualification and other basic eligibility criteria will be summarily rejected.
- O. One Time Registration is not an application for the Post / Recruitment. Though the details / particulars were furnished in the One Time Registration by the applicants, the details / particulars were furnished in the online application for this recruitment <u>alone</u> will be taken into consideration. Tamil Nadu Public Service Commission will not be responsible for any consequences arising out of furnishing of incorrect and incomplete details in the application or omission to provide the required details in the application for this recruitment.

#### 13. OTHER IMPORTANT INSTRUCTIONS

- a) Applicants should ensure their eligibility for examination. ## ORDER:

The Hon'ble Minister (SW&NNMP) among others have made the following announcement on the floor of the House on 06.06.2018:-

மாற்றுத் திறனாளிகள் நலனில் மிகுந்த அக்கறை கொண்ட இந்த அரசு மாற்றுத் திறனாளிகளுக்கான உரிமைகள் சட்டம், 2016-ன் படி மாற்றுத் திறனாளிகளுக்கு அரசுப் பணிகளில் 4% இடஒதுக்கீடு வழங்க ஏற்கனவே ஆணை வழங்கியுள்ளது. இந்த இடஒதுக்கீட்டினை செயல்படுத்தும் விதமாக தொகுதி 'A' மற்றும் 'B' பிரிவு, நேரடி நியமனங்களில் மாற்றுத் திறனாளிகளுக்கு உகந்த பணியிடங்கள் கண்டறியப்பட்டு, விரைவில் ஆணை வெளியிடப்படும்.

2. As per section 33(i) of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) "the appropriate Government shall identify posts in the establishments which can be held by respective category of persons with benchmark disabilities in respect of the vacancies reserved in accordance with the provisions of section 34" of the said Act.

- 3. In the Government order second read above, 263 posts under group A & B category were identified as suitable for differently abled persons under 3% reservation. In the Government order third read above Government have issued orders for increasing the percentage of reservation of differently abled persons in employment from 3% to 4%.
- 4. In the Government order fifth read above, an Expert Committee for identifying Groups 'A', 'B', 'C' and 'D' posts have been constituted as per section 33(i) of the Rights of Persons with Disabilities Act, 2016.
- 5. In the Government order fourth read above, in Group 'A' and 'B' categories three posts like Civil Judge and District Judge (entry level), Post Graduate Teacher and Physical Director (Grade-I) were identified, in the Government order sixth read above certain amendment was made for the Civil Judge and District Judge (entry level) and in the Government order seventh read above, Personal Assistant to Hon'ble High Court Judge, Interpreter and Senior system analyst were identified for most suitable for differently abled persons.
- 6. In the letter eight read above, the State Commissioner for the Differently Abled has sent proposals for identifying posts suitable for differently abled persons under Group 'A' and 'B' categories based on the opinion of the Expert Committee for consideration.
- 7. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled, in consultation with all the concerned departments have decided to approve 229 posts under 'A' and 'B' categories and six posts already identified in Government orders 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> read above. Totally 235 posts under Group 'A' and 'B' categories are most suitable for differently abled persons. In respect of posts comes under other departments, boards and corporations will be identified and issue orders separately.
- 8. The Government also direct that 4% of the vacancies in direct recruitment for the identified posts in 'A' and 'B' Groups, where the rule of reservation is applicable for the SCs / STs / BCs and other communities, shall be reserved for the Differently Abled Persons. If only one post is available for recruitment in these categories, the usual procedure for recruitment will be followed. The Government has also directed that,
  - (i) The reservation of 4% vacancies earmarked for the differently abled persons will be applicable to indentified posts in respect of 'A' and 'B' categories for direct recruitment posts only.
  - (ii) The reservation of 4% vacancies for differently abled persons need not be made applicable in the case of recruitment by transfer/promotion as it would amount to giving double preference to these candidates.
  - (iii) If any department / establishment is of the view that any particular post in 'A' and 'B' category is not suitable for differently abled persons, in such case, it may specifically request the Government for exemption. The administrative department in consultation with the State Commissioner for the Differently Abled and the Government shall issue appropriate orders.
  - (iv) The individuals selected for 'A' and 'B' categories of posts should be asked to produce certificate of physical fitness and the disability certificate as stated in section 3(oo) of Tamil Nadu Government Servants (Conditions of Service) Act, 2017.

- 9. The list of 235 categories of posts identified as most suitable for the different categories of the Differently Abled Persons for 4% reservation in 'A' and 'B' groups is given in the Annexure to this order.
- 10. Government also direct that the effect of the Government Order will be from the date of notification.

## ORDER:

In the Government Order first read above, orders were issued reserving 3% of vacancies in Government and Government undertakings for Differently Abled Persons.

- In the Government Order second read above, reservation of 3% vacancies has been provided for physically handicapped persons to the Executive post in respect of 'C' and 'D' categories.
- 3. In the Government Order fourth read above orders were issued for increasing the percentage of reservation of differently abled persons in employment from 3% to 4% in all State Public Services / Public Sector Undertakings / Boards / Corporations / Educational Institutions under all kinds of Managements (like Government, Local Bodies and Aided Management including Universities).
- 4. In the Government Order fifth read above an expert committee has been formed for identification of posts suitable for differently abled persons in employment in respect of group 'A', 'B', 'C' and 'D' categories as per section 34 of the Rights of Persons with Disabilities Act, 2016.
- 5. In the letter sixth read above the State Commissioner for the Differently Abled has submitted proposals based on the recommendation of the Expert Committee that 4% reservation of posts earmarked for the differently abled persons shall be applicable as earlier to all the posts in respect of 'C' and 'D' categories. He has also stated that the proviso to Section 34(1) of the Rights of Persons with Disabilities Act, 2016 gives power

to the Government to exempt any establishment from the 4% reservation. If any department / establishment is of the view that any particular post in 'C' and 'D' category is not suitable for differently abled persons, in such case, it may specifically apply to the Government in the administrative department in consultation with the State Commissioner for the Differently Abled and the Government shall issue appropriate orders. Further he has requested the Government to issue appropriate orders in this regard.

6. After careful examination of the proposal of State Commissioner for the Differently Abled, the following orders are issued:-

(i) the reservation of 4% vacancies earmarked for the differently abled persons will be applicable to all the posts in respect of 'C' and 'D' categories in employment.

(ii) the reservation of 4% vacancies for differently abled persons need not be made applicable in the case of recruitment by transfer/promotion as it would amount to giving double preference to these candidates.

(iii) If any department / establishment is of the view that any particular post in 'C' and 'D' category is not suitable for differently abled persons, in such case, it may specifically request the Government for exemption. The administrative department in consultation with the State Commissioner for the Differently Abled and the Government shall issue appropriate orders.

(iv) the individuals selected for 'C' and 'D' categories of posts should be asked to produce certificate of physical fitness and the disability certificate as stated in section 3(oo) of Tamil Nadu Government Servants (Conditions of Service) Act,

2017.

## ORDER:-

In the Government Order first read above, orders were issued that Third Gender may register their names in Employment Exchange offices based on the certificate identifying them as Transgender issued by the Tamil Nadu Transgender Welfare Board (TGWB) and to sponsor their names for appointment in the vacancies reserved for women category namely 30% and as well as vacancies reserved for General Category (both Men and Women) namely 70%.

- 2. In the Government Order second read above, orders were issued classifying the "Transgender of Eunuch (Thirunangai or Aravani)" as Most Backward Class by including at SI.No.36-C in the list of Most Backward Classes.
- 3. In the Government Order third read above, among other things orders were issued, that Transgender will be identified as 'Third Gender' apart from the Binary Gender System and they have the right to decide their self-identified gender as male or female or as the third gender.
- 4. The Secretary, Tamil Nadu Public Service Commission in the D.O. letter fourth read above has sought for following clarifications in this matter with regard to:-
  - (i) Considering the Transgender under 30% reservation for Women

- (ii) Treating the Transgender candidates who have claimed communal status under Scheduled Caste/ Scheduled Caste (A)/ Scheduled Tribe by producing respective Community Certificate confirming their claim.
- 5. After careful examination, in consultation with the concerned departments and the Director of Social Welfare, the Government hereby issue the following order regarding the determination of community and reservation in employment for the Third Gender in order to streamline the procedures to be followed by the recruiting agencies like Tamil Nadu Public Service Commission, Teachers Recruitment Board, Uniformed Services Recruitment Board, Medical Recruitment Board, etc., and Employment Exchange offices / appointing authorities, in sponsoring / recruiting / selecting the Third Gender candidates for appointment in Government Service:-

## **Determination of the Community:-**

- (i) The Third Gender candidates, who do not possess any community certificate may be considered under Most Backward Class as per G.O.(Ms).No.28, Backward Classes, Most Backward Class and Minorities Welfare Department, dated 06.04.2015.
- (ii) The Third Gender candidates who belong to Scheduled Caste/Scheduled Caste (A)/Scheduled Tribe communities, and possess community certificate as such, may be considered as per their respective community.
- (iii) The Third Gender candidates who belong to the communities other than Scheduled Caste/Scheduled Caste (A)/Scheduled Tribe and possess community certificate as such (not covered under point (i) above) may be considered as per their own community or as Most Backward Class whichever is advantageous to them as per their option and once the individual exercises option for community selection it should be crystallized and this option should not be changed in future.

## Reservation in Employment:-

- (i) The Third Gender candidates who identify themselves as "Female" by self-declaration supported by the certificate (ID card) issued by the Tamil Nadu Third Gender Welfare Board (TNTGWB) may be considered against both 30% reservation for women as well as 70% reservation for the General category (both Men & Women).
- (ii) The Third Gender candidates, who identify themselves as "Male" or "Third Gender", may be considered against the 70% reservation for General category (both Men & Women) as the case may be.

The above concessions may be granted subject to production of certificate identifying them as Third Gender or Third Gender (Male) or Third Gender (Female) issued by the Tamil Nadu Third Gender Welfare Board (TNTGWB), as the case may be.
