- 1. Age limit for JRF is 28 years and SRF is 32 years but age relaxation will be considered as per Government of Tamil Nadu norms for reserved category candidates.

The candidates appearing for written tests and personal interview will report at Advanced Institute for Wildlife Conservation (Near Vandalur Zoo), Vandalur, Chennai-600048 along with original application and documents. Once the applications have been screened date of the written test for the eligible applicants will be intimated by email and texts on their email address and cell phone no, which are mentioned on their applications. Only those candidates who have qualified in the written tests will be called for the interview following the same procedure as the above.
- 3. Application should be in the prescribed format, duly signed and should be accompanied by self-attested copies of documents on educational qualifications, research experience, UGC/CSIR/GATE certificate (if any), extracurricular activities, date of birth, mark sheets of all examinations, community certificate (if sought relaxation as per Government of Tamil Nadu rules), etc.
- 4. The Institute will not provide accommodation and no TA/DA will be paid to the candidates appearing for the written examination and subsequent personal interview.
- 5. At the time of the verification of original documents or even after selection, if it is found that an attempt has been made by the applicant to wilfully conceal, misrepresent or canvass the facts, such application will be rejected, and due action will be taken against the candidate.
