Short Title: TNUSRB – Common recruitment for the posts of Gr.II Police Constables, Gr.II. Jail warders and Firemen for the year 2020 - Nomination of Super Check Officers, Sub-Committee Chairman and Members for Physical Measurement Test, Endurance Test, Physical Efficiency Test and Certificate Verification at 41 centres – Orders Issued - Regarding.

Read: Letter in C.No. R2 /5757/2020, dated 09.02.2021 of the DGP/Chairman, TNUSRB, Chennai.

ORDER:

The TNUSRB, Chennai has issued notification for common recruitment - 2020 on 17.09.2020 for filling up the post of Gr.II. Police constables, Gr.II Jail warders and Firemen. The written examination for the Common Recruitment for the posts of Gr.II.PCs, Gr.II. Jail Warders and Firemen for the year 2019 has been conducted on 13.12.2020.

2) In the letter read above, the DGP/Chairman, TNUSRB, Chennai has proposed to conduct the next stage of recruitment i.e. Physical Measurement Test, Endurance Test, Physical Efficiency Test and Certificate Verification for the qualified candidates at 41 centres in the month of March-2021. Hence the Tamil Nadu Uniformed Services Recruitment Board has suggested for formation of Sub-Committee consisting of Officers as detailed below:-

3) Further he has stated that if the chairperson of the Sub-committee nominated in the rank of Deputy Inspector General of Police, the Super Check Officer in the rank of Inspector General of Police may be nominated and if the Chairperson of the Sub-Committee nominated in the rank of Superintendent of Police, then the Super Check Officer in the rank of Deputy Inspector General of Police may be nominated for the Centres in order to have a close watch and to prevent malpractices during the selection.

4) Accordingly, the Sub-Committees have been constituted for the 41 Centres and the officer nominated as Sub-Committee Chairman, Member-I, II, III for each Centres are furnished in **Annexure-B** to this proceedings. In order to have a close watch and to prevent malpractices during the selection, Super Check Officers are also nominated in the rank of Inspector Generals of Police/Deputy Inspector Generals of Police to the 41 Centres. Their names are furnished in **Annexure-A** to this proceedings.

5) The change of Officers for Sub-Committee Members -I, Member-II, Member-III, if any required due to unavoidable circumstances may be ordered by the Zonal IGP's in time and the fact may be intimated to Chief Office & to the Director General of Police/Chairman, TNUSRB Chennai.

6) The Officers nominated as Super Check Officer for the above selection are requested to supervise the work in order to have close watch and to prevent malpractices during the selection carefully.

7) The respective Additional Director General of Police, Commissioner of Police/Inspector Generals of Police/ Deputy Inspector Generals of Police and Special Units will make necessary additional charge arrangements and depute the officers nominated for Sub-Committee without fail.

8) The Commissioners of Police in Cities / Superintendents of Police in Districts are requested to make necessary arrangements regarding Ground, Shamiyanas/Tents, CCTVs, Nomination of Sports Officials, Doctor for Appeal Committee along with Para-Medical Team with Ambulance and other required items etc.

9) In view of anticipated Bandobust / Law & Order exigencies with reference to upcoming elections, the Officers from Special Units have been drafted for conducting recruitment process at City Police / District Headquarters. However, it is reiterated that it is the responsibility of respective COPs/SPs to ensure smooth conduct of recruitment process by extending all assistance to the Chairmen of Sub-Committees.
